Registerable Interests Criteria are set out in further detail in the Code of Conduct for Board Members of SRH

- **Remuneration** remunerated employment, self-employment or directorships;
- Related undertakings unremunerated directorships where the company (or the undertaking) in question is a subsidiary of, or a parent of, a company (or other undertaking) in which you hold a remunerated directorship
- Contracts contracts between SRH and you or another party in relation to whom you have declared an interest;



- Gifts and hospitality to be declared separately on the SRH Directors' Register of Gifts and Hospitality can also be found on SRH website
- Houses, land and buildings that you own or have an interest in which are of significance or relevance to, or bear upon the work and operation of, SRH or its subsidiaries;
- Shares and securities holdings in a company or organisation which are of significance or relevance to, or bear upon the work and operation of, SRH or its subsidiaries; and
- Non-financial interests including membership or holding office in other public bodies, clubs, societies, and organisations such as Trade Unions and voluntary organisations.

 Membership of sports clubs or other organisations of a non-political nature which do not have significance or relevance to, or bear upon the work and operation of, SRH or its subsidiaries need not be declared unless or until circumstances arise which would constitute such a significance, relevance or bearing.

Notes:

- Where applicable, Non-Executive Director status should be noted.
- This register details the interests of all current directors and other persons who have been a director during the company's current or preceding financial year.
- The interests of former directors are not updated after their date of resignation.
- Only information current at the date of appointment to SRH, and thereafter, needs to be included in the register. If a director resigned from a post/role prior to being appointed to SRH, the previous role need not be recorded. If a director held a post/role at date of appointment to SRH and subsequently resigned from that post/role, this should be recorded with the date of resignation added.
- SRH Directors should make required changes to the register as soon as possible and in any event within one month of the change occurring.
